El Paso County has been working with the El Paso Coalition for the Homeless and a membership-based task force since 2013 in designing and operating a Coordinated Entry System (Coordinated Access) that is consistent with HUD expectations and assures the implementation of coordinated assessment offers the following opportunities:

- Increased Referral Appropriateness – The County was able to standardize the assessment process, so clients can be assessed using consistent standards and matched to projects according to client need, eligibility, and preferences. Increased Fairness - Consistent assessment protocols and coordinated data

systems allow County specialists to assess all clients equally and to match them according to need and vulnerability. Clients gain an opportunity to equally access all of the services in the community, regardless of the client’s location or point of entry.

- Reduced Administrative Burden on Clients and Providers - Coordination reduces total assessment time by quickly capturing the most relevant information and forwarding/sharing it with appropriate community partners, reducing the number and length of interviews and limiting clients’ need to retell often traumatic histories. Likewise, it also reduces the data collection and entry burden on providers, who can focus more on assisting clients than capturing information and documentation that has already been provided.

- Improved Provider Coordination – The County has implemented standardized processes and coordinated data systems that increases provider system awareness, communication and collaboration. Through collaboration, trust between organizations increases and commitments deepen.

- The Vulnerability Index–Service Prioritization Decision best available evidence to examine the components of a person or family’s life that are most likely to result in housing instability. The VISPDAT helps to understand the depth of these issues; which household is most likely to benefit from which type of housing support intervention; which household should be prioritized above others based upon their acuity; and informs the case management process so staff spend their time working on those issues that are most likely going to result in the person/family becoming homeless again. In addition the VISPDAT allows for case managers to better assess when a client is no longer in need of the intensive supports offered in PSH.

The County has partnered with the City of El Paso 211 Information line to screen and direct coordinated entry service calls to the designated locations for assessment. In addition, 211 Information line will address the "after hours" calls. In collaboration with the City and the El Paso Coalition for the Homeless, press releases will be issued to announce the process and educate the community about coordinated entry. The hotline, as well as addresses of the three sites, will

be posted on the Coalition's website, City's website, and County's website. Digital and print media will be utilized for advertisement of the coordinated entry process. The County and CoC will work with multiple entities, including the Downtown Management District, El Paso Police Department, hospitals and other institutions, to promote this service throughout the community, assuring that those with the highest barriers are aware of the system, and will work with existing shelters to ensure they are assisting in making this effort successful, including direct contact with emergency shelters residents that were not previously screened and evaluated.

Upon contacting the Coordinated Entry System staff, either through the three City facilities or the County Coordinated Entry System Hotline, clients are screened using the VISPDAT tool. After the evaluation is complete, the HMIS-based CA System provides a list of providers which meet the specific needs of the client based on the screening tool. Information on those specific shelters and services, which provide the best fit, are given to the client including contact information and directions to the recommended facility. The referral is generated and sent via email through the HMIS system directly to the provider. For entities not participating in HMIS, the referral is accomplished via telephone. Once a referral is accepted by the provider, the HMIS-based CA System will identify the provider and that the client is now receiving services. For those not accepted, they remain in an online "queue" so they can be referred to an alternate program. Coordinated entry staff review referrals, acceptances and denials daily to ensure client need is addressed as quickly as possible.
