### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

The housing herein consists of one-bedroom apartments in a single building, each with its own kitchen and bathroom. The focus population are chronically homeless individuals. Sufficient additional space in the building will also be allocated and developed to provide for on-site supportive services to be provided by Emergence Health Network of El Paso.

The primary emphasis of Emergence Health Network of El Paso is to develop a self-sufficiency plan with the individual. This plan will focus on stabilizing the individual, and assessing which supportive services client needs to be provided.

Emergence Health Network (EHN) will focus on client’s self-sufficiency and independence objectives. EHN will provide training, support and assistance to consumers for food acquisition and proper storage, meal preparation, essential nutrition, home cleaning and upkeep, and other self-sufficiency issues wherein a fully independent apartment is more appropriate and conducive to achievement of the objectives.

Also, consumers' sense of true independence and personal stability will be greatly enhanced through occupancy of their own independent apartment as compared with a SRO hotel-like or community living center arrangement, which lend themselves rather to a feeling of temporary or transitional housing.

The sense of stability is critical to the maintenance and improvement of the mental and emotional health status of this population.

All essential community amenities are easily and conveniently accessible from this site, either by being located within easy walking distance or accessible through bus transportation, with a bus stop within two blocks of the facility. Amenities include a full grocery store less than a mile away, and multiple convenience stores nearby; a Laundromat approximately two blocks' distance; several hospitals, doctors ' offices, and medical clinics less than a mile distant; a public library, parks, and recreation facilities within a mile of the site; the University of Texas at El Paso and El Paso Community College campuses within a mile of the facility; several churches and other houses of worship in the neighborhood; and the main outpatient center for Emergence Health Network of El Paso less than a mile distant. All standard amenities are either located a mile or less from the project site or are conveniently accessible via the bus route located nearby.
