CASFV has been working with victims of domestic violence for over 40 years and added victims of sexual assault to our cadre of case management 6 years ago. CASFV has operated an Emergency Shelter for victims of domestic violence for 38 years. In those 40 years, CASFV provided Rapid Re-Housing for 3 years under a Texas ESGP grant and for 1 year through a City of El Paso CoC grant. CASFV has over 30 years in implementing state and federal grants. CASFV has well-established accounting procedures that meet AICPA requirements for not-for-profit organizations and applicable OMB Circulars. It also has excellent client and service record keeping policies and procedures to ensure that all programmatic grant requirements are met.

2. Describe the experience of the applicant and potential subrecipients (if any) in leveraging other Federal, State, local, and private sector funds.

CASFV will utilize private and local funds to leverage against the project. We will utilize in-kind and private donations as a match for the project.

3. Describe the basic organization and management structure of the applicant and subrecipients (if any). Include evidence of internal and external coordination and an adequate financial accounting system.

CASFV has 84 employees of which 54 are full time and 40 are part time. CASFV has a management team of 10 directors and associate directors who manage the agency all led by the Executive Director. CASFV also has a board of 24 business and community leaders. CASFV has an annual budget of \$4.2 million made up of local, state and federal dollars and including 30% from private sources. The Center Against Sexual and Family Violence (CASFV) was incorporated in 1977. It has evolved over the past 40 years to become the largest provider of domestic violence and sexual assault services on the US/Mexico border. Its services for survivors of domestic violence or sexual assault include emergency shelter, lodging, advocacy, counseling, therapy, legal assistance, employment assistance, housing assistance, transitional living, and hospital accompaniment.

1. Provide a description that addresses the entire scope of the proposed project.

CASFV is proposing to provide Rapid Re-Housing for 20 Emergency Shelter Families who are survivors of domestic violence or sexual assault. Families who are living in the Emergency Shelter because they are in immediate danger but have capability of moving into permanent housing directly from the shelter will be triaged as candidates.

DV Bonus Permanent Housing-Rapid Re-Housing will assign a part-time case worker who work with the clients to promote self- sufficiency through individual service plans, counseling and monitoring to secure coordinated services. The Emergency Shelter Advocates will make referrals to the case worker. The referrals will be families who reside in the Emergency Shelter but have the capability of relocating into permanent housing and do not require an incubation period in a TLC. They will be clients who are in immediate danger but are employed and are willing to move into permanent housing. We anticipate being able to serve 20 families a year. While in permanent housing the case worker will be able to provide supportive services.

The case manager will be a part-time position which will provide the following for clients receiving Rapid Re-Housing vouchers. Specific tasks include:

- Rental assistance- clients will qualify for support based on income or ability to gain income. Length will be determined on stability and can be provided for up to 24 months.
- Monthly check-ins
- Periodic home visits
- All clients will still qualify for all CASFV supportive services
- Case management and development of individualized service plan that are regularly monitored
- Educational assessment and appropriate referral/placement to improve job skills, to include a requirement that all TLC clients without a high school diploma must enroll in GED classes
- Participation in support groups, therapy, legal advocacy and related services for domestic violence and sexual assault related issues, parenting classes, life skills classes
- Participation in financial literacy education to include enrollment in a savings plan for all residents of the TLC, plus participation in consumer credit counseling classes as necessary
- Job readiness training to include computer classes, placement and referrals for employment and support
- Referral and access to other agencies for needs beyond CASFV's capacity, particularly members of the El Paso Coalition for the Homeless,
- Transportation assistance through vouchers
- Child care assistance and vouchers
