This program entitled RRH for the Chronically Homeless is inclusive of the community wide response to assuring housing and services to the chronically homeless. We recognize the value of and support housing first initiatives at the federal level. It is recognized for this initiative to be successful at the community level –enhancement through intensive case management is critical, both during placement and even more so for sustainability. Services as it relates to sustainability are many times restricted through public funding sources. Our partnership with the Hogg Foundation for Mental Health allows us to fulfill the critical need of supportive service availability upon placement in both permanent supportive housing and permanent housing.

Participants of the program are provided direct access, on a voluntary basis, to intensive case management services and counseling services specific to their individual needs. The proposed staffing of the facility includes a full time project coordinator. This person is responsible for the overall day to day operations of the project. She/he will also be involved with the day to day interaction and professional assessment of residents prior to and throughout their participation, as well as follow up and placement, if applicable.

The overall program goals are to; provide residential stability for program residents, increase skill level and/or income of participants, and to increase self-determination of participants. Each participant works with their case manager in developing a treatment / transition plan with mutually agreed goals. The individual plans take into account their personal goals to include education and employment, dependency needs, physical health, social and interpersonal skills, financial goals, and housing.
