Update for Report Generating

Bitfocus is still working on updating their servers to help in updating client files in HMIS to generate reports faster.

When generating reports, please keep in mind:

- If a clients profile is updated with any information, please allow up to 30 minutes for servers to update before running reports for correct and updated information to show. (This has been updated from 1 hour to now 30 minutes)
- Reports should not take more than 5 minutes to generate (Depending on information you are asking for. The more information to generate, the longer it may take.
- If information is not correct on reports, please let Gary or Denver know so we can look into the issue. A help desk ticket to Bitfocus may be needed.

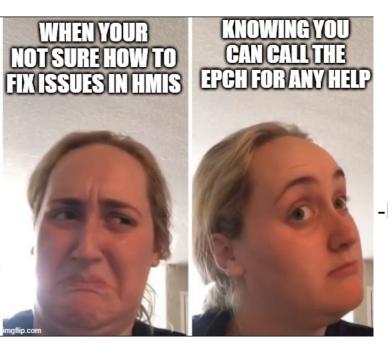
