Clarity Update-May 2023

- May 2023 update will be live on May 22, 2023.
- Update includes an option to add Pronouns to the Client Profile



Clarity Human Services: May 2023 Feature Updates

Release Schedule:

- All Training Sites: Monday, May 8, 2023
- All Production Sites: Monday, May 22, 2023

Clarity Update-Pronouns Field

- A new **Pronouns** field is available for System Administrators to add to the <u>Client</u> Profile screen if desired.
- The Pronouns to be used are below:
 - "She/Her/Hers"
 - "He/Him/His"
 - "They/Them/Theirs"
 - "Manual Entry" (Users can manually enter custom pronouns for clients)
 - "Client doesn't know"
 - "Client refused"
 - "Data not collected"

Keep in mind that this is NOT a requirement by HUD Data Standards and will not affect reporting. This is <u>OPTIONAL</u> for our community.

Clarity Update-Pronouns Field

• If a user enters pronouns for a client, the pronouns will appear in parentheses after the client name in all locations throughout the system where the client name is displayed. If the client has an alias, the pronouns will appear first, followed by the alias. Any user with permission to view client names will be able to see the pronouns.




Note: No pronouns will be displayed for the client if any one of these conditions is true:

- The Pronouns field has not been added to the Client Profile screen.
- The value for the Pronouns field is "Select," "Client doesn't know," "Client refused," or "Data not collected."
- The user selects "Manual Entry" for the Pronouns field but does not enter any text in the Pronouns Manual Entry field.

Clarity Update-Pronouns Field

- The Pronouns field will be added under Ethnicity for users to choose.
- Below is what it will look like when a user chooses "Manual Entry".




If **Pronouns Manual Entry** is added to the profile screen, System Administrators may set up a Display Constraint if desired so that **Pronouns Manual Entry** will only appear on the screen if the user selects "Manual Entry" for the **Pronouns** field.

- This is the current timeline for the new HUD HMIS Data Standards to go live Oct 1st, 2023.
- HUD has just released the HUD Data Standards Manual in the HUD Exchange!

Rapid Re-Housing project

- When a new RRH program is built for your agency, you will have to let us know what sub type it will be.
- Whether you have a Services Only type subtype, or if you have a Housing With or Without Services.

Retired Data Elements

- The following elements will be retired from all HMIS systems.
- This does not mean they are going away, they are being mapped with other elements.
 - 3.05 Ethnicity
 - 4.19 Coordinated Entry Assessment
 - 4.20 Coordinated Entry Event
 - Ethnicity is merging with Race
 - Coordinated Entry Assessment and Events will be mapped into a new element.
- More information will be given in the later months.



Race & Ethnicity

- Race and ethnicity will now be joined together as one element.
- You will be able to choose one or multiple if needed.

- The Gender section will update with specific genders as their own answer.
- You will still be able to manually enter an answer if one is not listed.

Updated Data Elements

- Replaced "Client refused" with "Client prefers not to answer" in all elements
- 3.01 Name
 - Change data collection instructions to indicate "legal name" not required unless required by a funder
- 3.02 Social Security Number
 - Data collection instruction change for HUD CoC and ESG programs. Only last 4 digits required to be collected.
- 3.07 Veteran Status
 - Definition specifics taken out of Data Standards Manual directed to VA Data Guide for current legal definition
- Health Insurance response "Veteran's Administration (VA) Medical Services" changed to "Veteran's Health Administration (VHA)"

 When choosing Rental By Client, with Housing Subsidy, the system will now ask you to identify what Rental Subsidy Type.

- The "Approximate Date Homelessness Started" was confusing a lot of HMIS users, so HUD made an update to clarify.
- It will now say "Approximate Date This Episode of Homelessness Started".

• This field will not change, just the wording of the question on the enrollment screen.

Federal Partner Program Elements

- CoC PSH projects collect Sexual Orientation
- Services Provided response of "Substance <u>abuse disorder</u> services/treatment" changed to "Substance <u>use</u> services/treatment"
- Medical Assistance removed the "Receiving Public HIV/AIDS Medical Assistance" response.
- **Changed** responses "client went to jail/prison" and "client died" to "jail/prison" and "deceased"
- RHY elements in general changed "youth" to "client"
- **Changed** "Post-natal care for mother" to "Post-natal care for client (person who gave birth)"
- Wellbeing, Worst Housing Situation and Last Permeant Address elements will be retired.

Translation Assistance

 Translation Assistance will need to be captured for all HUD: CoC, ESG and HOPWA programs. This will only be captured for the Head of Household.


"Past experience of homelessness (Street/Shelter/Transitional Housing)"


