- Update includes Recovering Deleted Data & Security update to the system




Clarity Human Services: July 2023 Feature Updates

Clarity Update-Deleted Data


- When data is deleted per your request by HMIS admins, we have the ability to restore that data in case it was a mistake.
- However, when certain data is deleted, some information may not come back.

Data Flow: RRH & PSH

Time to have a conversation!

Sometimes we forget that data needs to be entered or shown in a certain way. So we wanted to talk about the process from beginning to end for all the different program types.

- Providing Services
- Case Notes & Documentation
- Other tools in HMIS used
- Exiting from program

Translation Assistance Needed

With the new HUD HMIS update, a new question will need to be asked when enrolling a client into any CoC, ESG and HOPWA program.

The question will ask if Translation Assistance is needed for the Head of Household. If Yes is selected you will be able to choose from a list of 20 languages.

- HUD has identified a total of 327
 Languages. Out of that list, we as a community need to choose up to 20 to try to capture that in the data.
- Even if one is not listed, you can still use "Different Preferred Language" and type out which language the client uses.

Survey for Translation Assistance

We would like the community's input on what other languages (Other than English and Spanish) you may have come across.

We will be sending out a short survey with a list of Languages we think may be used in El Paso and want to know if you agree with the list or would like to see some changes to the listing.

We want to have the list ready for the October 1st update, so we can implement it and monitor the data.

Keep in mind, this list is not "Set in Stone". We have the ability to change any of the listed languages at any time.

Please fill out the survey as soon as possible so we can gather all answers and have a "final" list prior to the October 1st update.


